MINUTES

- I. Call to Order, Pledge of Allegiance, and Roll Call:** President Thaler called the meeting to order at 10:01 a.m. and led the Pledge of Allegiance. Deputy Town Clerk Cooper called the roll: Susan Thaler, Christina Adams, Ira Friedman, and Robert Jurovaty were present. Michael Hill was absent with notice; James McCormick was absent; and John Skrandel was excused.
- II. Additions, Withdrawals, Deferrals, and Arrangement of Agenda Items:** None
- III. Announcements:**
 - a. The Town Election scheduled for Tuesday, March 15, 2016, was not required to be held and was cancelled. The incumbent Mayor and the three incumbent Aldermen filed for re-election and were unopposed.
 - b. The Proclamation of Results of the Town Election was passed and adopted by the Town Council at its Regular meeting January 28, 2016, announcing the re-election of Mayor Hill for a one-year term and the election of Aldermen Christina Adams, Robert Jurovaty, and James McCormick for two-year terms

Nominate (Thaler/Adams) Robert Jurovaty as Town Clerk Pro Tem; call for other nominations; motion to close nominations (Thaler/Adams); motion to appoint Robert Jurovaty as Town Clerk Pro Tem (Thaler/Friedman), after a call for public comment, motion passed unanimously; Deputy Town Clerk Cooper administered the Oath of Office to Robert Jurovaty as Town Clerk Pro Tem.
Nominate (Adams/Friedman) Sue Thaler as Town Council President, call for other nominations; motion to close nominations (Jurovaty/Friedman); motion to appoint Sue Thaler as Town Council President (Jurovaty/Friedman), after a call for public comment, motion passed unanimously; Town Clerk Pro Tem Jurovaty administered the Oath of Office to Sue Thaler as Town Council President
 - c. Consideration of Res 2016-6 Appointments to Town Positions for the New Council Year: MOTION made and seconded (Friedman/Adams) to adopt Resolution 2016-6; after a call for public comment, motion passed unanimously.
